HT Tennis Membership Guidelines

- All players & guests must sign in using the QR Code provided
- Masks, sanitising and social distancing should be followed whenever possible
- Courts cannot be booked
- Court entry is via the gate facing the gymnasium with sign above it
- Appropriate footwear must be worn
- Members can bring up to two guests
- People other than your guests should not be admitted to the courts without their own key
- No food or drink to be taken onto the court surface
- Courts must be locked when you have finished playing
- Replacement key cost is \$25
- Membership expires annually on 28 February
